5 were noted on the record after due and proper notice.


6 The Court, after considering the moving papers, and for good cause shown, it

8 (1) The Special Master's final accounting and report is approved.

10 (3) The payment of \$68,038.44 from the Defendants' Assets consisting of:
11 (a) the fees and expenses of the Special Master and his accounting personnel and
12 staff in the sum of \$59,818.44 for the period from May 1, 2011 through July 31,
13 2011 (including estimates to close) (the "Final Reporting Period") and (b) the fees
14 and costs of the Special Master's counsel, Frandzel Robins Bloom & Csato, L.C.
15 ("FRBC") for the Final Reporting Period in the sum of \$8,220.00 are approved. The
16 United States Marshals Service shall pay this amount from one or more of the
17 Defendant Assets.
