**STIPULATED ORDER SETTLING
CLASS COUNSEL'S FEE
PETITION**

The Court has before it Class Counsel's Fee Petition. The Court heard argument regarding the Fee Petition in December 2000 and took the petition under advisement pending resolution of matters relating to the Receivership Estate.


Counsel for Class Plaintiffs, the Receiver, and the Federal Trade Commission have advised the Court that they have resolved their dispute regarding an award of fees and expenses to Class Counsel and incentive awards to Class Plaintiffs and have approved and stipulated to this Order as to form and content. The settlement calls for the Receiver to pay, in full and final resolution of Class Counsel's Fee

1 Petition, the sum of \$2,200,000.00 (the "Payment") as soon as practicable and
2 allows Class Counsel to pay, out of the Payment, up to \$10,000.00 to each Class
3 Plaintiff as an incentive award. The Court finds and concludes that Class Counsel,
4 the Receiver, and the FTC settled Class Counsel's Fee Petition as a result of good
5 faith, arm's-length negotiation and hereby APPROVES the settlement in all
6 respects.

7 The Court has reviewed the extensive record relating to Class Counsel's Fee
8 Petition. The Court finds and concludes that Class Counsel conferred benefits on
9 the Class and that the settlement as set forth herein is fair and reasonable and
10 therefore awards Class Counsel \$2,200,000.00 pursuant to the settlement and
11 directs the Receiver to wire transfer the Payment, as soon as practicable but in any
12 event within one (1) business day after the Court's signing of this Stipulated Order,
13 pursuant to wiring instructions from Susman Godfrey L.L.P., which shall distribute
14 the Payment among Class Counsel (and to Class Plaintiffs as an incentive award as
15 hereinafter ordered) as Susman Godfrey L.L.P. deems appropriate in its discretion.
16 The Receiver and the FTC shall have no responsibility or liability regarding the
17 distribution of the Payment among Class Counsel.


