7 Report of Activities [February 1, 2007 through June 30, 2007]; and (2) Approving
8 and Authorizing Payment of Receivership Expenses [April 1, 2007 through
9 September 30, 2007] (“Receiver’s Report/Fee Motion”), the Receiver seeks the
10 following relief:

11 (1) An order approving the Receiver’s Report of Activities for the period
12 of February 1, 2007 through June 30, 2007 (the “Receiver’s Eighth Report”) filed
13 with the Court on July 30, 2007 and confirming the Receiver’s activities described
14 therein;

15 (2) An order approving and authorizing payment of receivership expenses
16 incurred for the six-month period from April 1, 2007 through September 30, 2007
17 (“Ninth Expense Period”), including payment of the fees of the Receiver, the
18 Receiver’s deputies, agents, staff and professionals, and reimbursement of costs
19 incurred during the Eighth Expense Period. The fees and expenses of the Receiver
20 and his staff incurred during the Ninth Expense Period total \$38,881.27 and his
21 legal fees and expenses, including those of outside counsel, incurred during the
22 Ninth Expense Period total \$143,381.58; and
