As the order approving the agreement between Global Forex Trading (GFT) and the Receiver was filed on July 17, 2008, the Initial Closing Date is July 24, 2008. GFT wired the \$100,000 compensation to the Receiver on July 18, 2008. The Receiver will send out a notice to customers on August 4, 2008 and transfer the customer funds to GFT on August 6, 2008. GFT should be able to get the customers started on trading or withdrawing funds shortly after the funds are transferred.

Based on the agreement between IKON Global Markets, Inc. (IKON) and the Receiver, IKON wired the \$100,000 compensation to the Receiver. IKON will notify the customers on July 28, 2008 that their accounts will be transferred to IKON, and that their funds will be available for either trading or withdrawal from IKON. The Receiver will transfer the customer funds to IKON on July 30, 2008. IKON should be able to get the customers started on trading or withdrawing funds shortly after the funds are transferred.
