**ORDER**

Upon consideration of the Motion by Plaintiff Commodity Futures Trading Commission (“Commission”) and Robb Evans & Associates, LLC, the Receiver, on behalf of Forex Liquidity (“FXLQ”), pursuant to Fed. R. Civ. Proc. 6 and L.R. 16.1 for an enlargement of time of an additional 60 days for defendant Forex Liquidity to answer or otherwise respond to the Complaint, and for a temporary stay or modification of the timetable for a discovery conference pursuant to Fed. R. Civ. Proc. 26(f) and for the issuance of a Scheduling Order pursuant to Fed. R. Civ. Proc. 16, and for good cause shown, it is hereby ORDERED that the Motion is GRANTED, and it is further ORDERED:

1. That the time to answer or otherwise to respond to the Complaint shall be extended up to and including May 30, 2008; and
2. That the time for parties to meet and confer pursuant to Fed. R. Civ. Proc. 26(f) shall be extended up to and including May 30, 2008. Any proposed scheduling order to be submitted in accordance with the terms of Fed. R. Civ.

1 Proc. 16 and L.R. 16.1 shall be submitted within 21 days thereafter, unless  
2 otherwise ordered by the Court.
