RECEIVER**


1 Pursuant to the joint stipulation entered into by Plaintiff Securities and  
2 Exchange Commission ("Commission") and Defendants Homestead Properties,  
3 L.P., Homestead Limited, L.L.C., California Wealth Management Group, d.b.a.  
4 IFC Advisory, Heath M. Biddlecome, William C. Tak, and Relief Defendants  
5 Homestead Northland MHC, LLC, and Jackson MHC, L.L.C., directly or through  
6 their attorneys of record, the Court orders as follows:

7 1. The Temporary Restraining Order and Orders: (1) Freezing Assets;  
8 (2) Prohibiting the Destruction of Documents; (3) Appointing Robb Evans &  
9 Associates LLC as temporary receiver over defendants Homestead Properties, L.P.,  
10 Homestead Limited, L.L.C., and relief defendants Homestead Northland MHC,  
11 LLC, and Jackson MHC, L.L.C. (collectively the "Homestead Entities") and Order  
12 to Show Cause Re Preliminary Injunction and Appointment of Permanent Receiver  
13 issued by this Court on November 16, 2009, and extended by Order dated  
14 November 23, 2009, shall be continued in its entirety from December 14, 2009,  
15 until December 18, 2009 at 5:00 p.m.

16 2. The hearing on the Order to Show Cause Re Preliminary Injunction  
17 and Appointment of Permanent Receiver shall be held on December 18, 2009 at  
18 9:00 a.m., or as soon thereafter as the parties may be heard, in the Courtroom of  
19 the Honorable Cormac J. Carney, United States District Judge.
