**ORDER EXPANDING THE
RECEIVERSHIP ESTATE TO
INCLUDE CERTAIN REAL
PROPERTY ASSETS OF
INDIVIDUAL DEFENDANTS
SHELDON FIDLER AND JUDITH
TAKALA FIDLER**

Plaintiff, the Federal Trade Commission ("FTC" or "Commission"), has moved this Court for an Order modifying the Stipulated Preliminary Injunction ("PI") issued by this Court on February 22, 2005 in order to expand the Receiver's powers to include certain real property assets of individual defendants Judith and Sheldon Fidler, namely: (1) a home located at 29 Via Mira Monte, Henderson, NV 89011 ("Nevada property"), and (2) a townhouse located at 10923 Landale St., #4, Toluca Lakes, CA 91602 ("California property"). Having considered plaintiff's motion, memorandum and exhibits filed in support of the motion, this Court finds sufficient cause to believe that the expansion sought by the FTC is warranted.

IT IS THEREFORE ORDERED that the FTC's Motion to Modify the PI is hereby granted, subject to the limitations set forth herein;

IT IS FURTHER ORDERED that, subject to the limitations set forth in this Order, the definition of "Receivership Defendants" in the Definitions of the PI is modified as follows:

"7. "Receivership Defendants" shall mean: (1) the Corporate Defendants and any other entities in active concert or participation with the Corporate

1 Defendants who receive actual notice of this Order by personal service or
2 otherwise, whether these entities are acting directly or through a trust,
3 corporation, subsidiary, division, or other device; and (2) individual
4 defendants Sheldon Fidler and Judith Takala Fidler with respect to their real
5 property assets at the following locations: (a) a house located at 29 Via Mira
6 Monte, Henderson, NV. 89011, and (b) a townhouse located at 10923
7 Landale St., #4, Toluca Lakes, CA 91602;”

8 **IT IS FURTHER ORDERED** that, with respect to the California property,
9 the Receiver shall take possession of the property, but under no circumstances shall
10 the Receiver take any action to sell or transfer the property or to dispossess the
11 Fidlers from residing in the property without the prior approval of this Court;

12 **IT IS FURTHER ORDERED** that, with respect to the California property,
13 the Receiver shall make all monthly payments due of mortgage principal and
14 interest, home owners association fees, taxes and insurance, with funds set off from
15 the monthly living expenses granted to the Fidlers in the PI;

16 **IT IS FURTHER ORDERED** that the Receiver shall take possession of the
17 Nevada property for the purpose of selling the property, and shall place all
18 proceeds from the sale of the property in the Receivership estate, but shall make no
19 disbursements from the sale proceeds without further Order of this Court;

20 **IT IS FURTHER ORDERED** that the Nevada property shall be sold with
21 the boat now moored at the property, and with all furnishings in the house,
22 excepting only family heirlooms and items of sentimental value to be identified by
23 the Fidlers, subject to review by the FTC and Receiver;

24 **IT IS FURTHER ORDERED** that the Fidlers shall have the right to move
25 this Court to modify prior orders limiting their access to frozen assets for living

1 expenses and attorney fees, including funds generated from the sale of the Nevada
2 property.


