The Motion for Order (1) Approving and Authorizing Payment of Receiver’s  
and Professional’s Fees and Costs from November 1, 2017 Through April 30, 2018  
and (2) Directing Turnover of Funds in Scottrade Account in Name of Homan  
Ardalan (“Motion”) brought by Receiver Robb Evans & Associates LLC  
 (“Receiver”) came on regularly for hearing on August 27, 2018 at 10:00 a.m. in

1 Courtroom 10C of the above-entitled Court, the Honorable S. James Otero, United  
2 States District Judge presiding. Gary Owen Caris of Barnes & Thornburg LLP  
3 appeared on behalf of the Receiver and other appearances were made as noted in  
4 the record.

5 The Court, having read and considered the Motion and all pleadings and  
6 evidence filed in support thereof, and opposition to the Motion, if any, and good  
7 cause appearing therefore, it is

8 ORDERED that:

9 1. The Motion and all relief sought therein is granted in its entirety;

10 2. Without limiting the generality of the foregoing, the following fees and  
11 costs incurred from November 1, 2017 through April 30, 2018 (“Second Expense  
12 Period”) are hereby approved and authorized to be paid from the assets of the  
13 receivership estate:

14 A. The fees of the Receiver, the Receiver’s members and staff of  
15 \$9,052.95 and Receiver’s costs of \$1,664.79, for a total of \$10,717.74;

16 B. The fees of the Receiver’s former counsel, Diamond McCarthy  
17 LLP of \$2,573.55 and its costs of \$27.75, for a total of \$2,601.30; and

18 C. The fees of the Receiver’s current counsel, Barnes & Thornburg  
19 LLP of \$14,112.80 and its costs of \$311.75, for a total of \$14,424.55.


20 3. The sums approved and authorized for payment in this Order shall be  
21 in addition to all sums previously requested to be approved and authorized for  
22 payment in its Motion for Order Approving and Authorizing for Payment of  
23 Receiver’s and Professional’s Fees and Costs From Inception of the Receivership  
24 Through October 31, 2017 (“Initial Expense Motion”) (Doc. 47).

25 4. All funds currently frozen in an account in the name of Homan  
26 Ardalan at Scottrade, Inc. in the amount of approximately \$303,052.78, with an  
27 account number ending in number 2838, shall be turned over to the Receiver as  
28 property of the receivership estate and may be used, to the extent necessary, to pay

1 for allowed fees and expenses as awarded in this Order and as may be awarded in  
2 connection with the Receiver's Initial Expense Motion (Doc. 47).

3 5. Notice of the Motion is hereby deemed sufficient under Local Rule 66-  
4 7 based on the service of the Motion on all parties and all known non-consumer  
5 creditors of the estate.
