The Motion for Order Approving and Authorizing Payment of Receiver's and  
Professional's Fees and Costs From Inception of the Receivership Estate Through September 30,  
2019 (Dkt. No. 81, "Motion") brought by Receiver Robb Evans & Associates LLC ("Receiver")  
was heard on January 9, 2020, at 10:00 a.m. Gary Owen Caris of Barnes & Thornburg LLP

1 appeared on behalf of the Receiver and other appearances were made as noted in the record.

2 As discussed on the record and for good cause, the Court grants the motion and orders that  
3 the following fees and costs incurred from the inception of the receivership on July 18, 2019,  
4 through September 30, 2019 (“Initial Expense Period”), are hereby approved and authorized to be  
5 paid from the assets of the receivership estate:

6 1. The fees of the Receiver, the Receiver’s members and staff of \$110,400.75, and  
7 Receiver’s costs of \$1,056.06, for a total of **\$111,456.81**; and

8 2. The fees of the Receiver’s counsel, Barnes & Thornburg LLP, of \$18,694.60, and  
9 costs of \$1,014.52, for a total of **\$19,709.12**.

10 The Court finds sufficient the notice of the Motion under Civil L.R. 66-6 and Civil L.R. 7-  
11 2, based on the service of the Motion on all parties, and service of notice of the Motion on the  
12 parties and all known potential non-consumer creditors of the estate.
