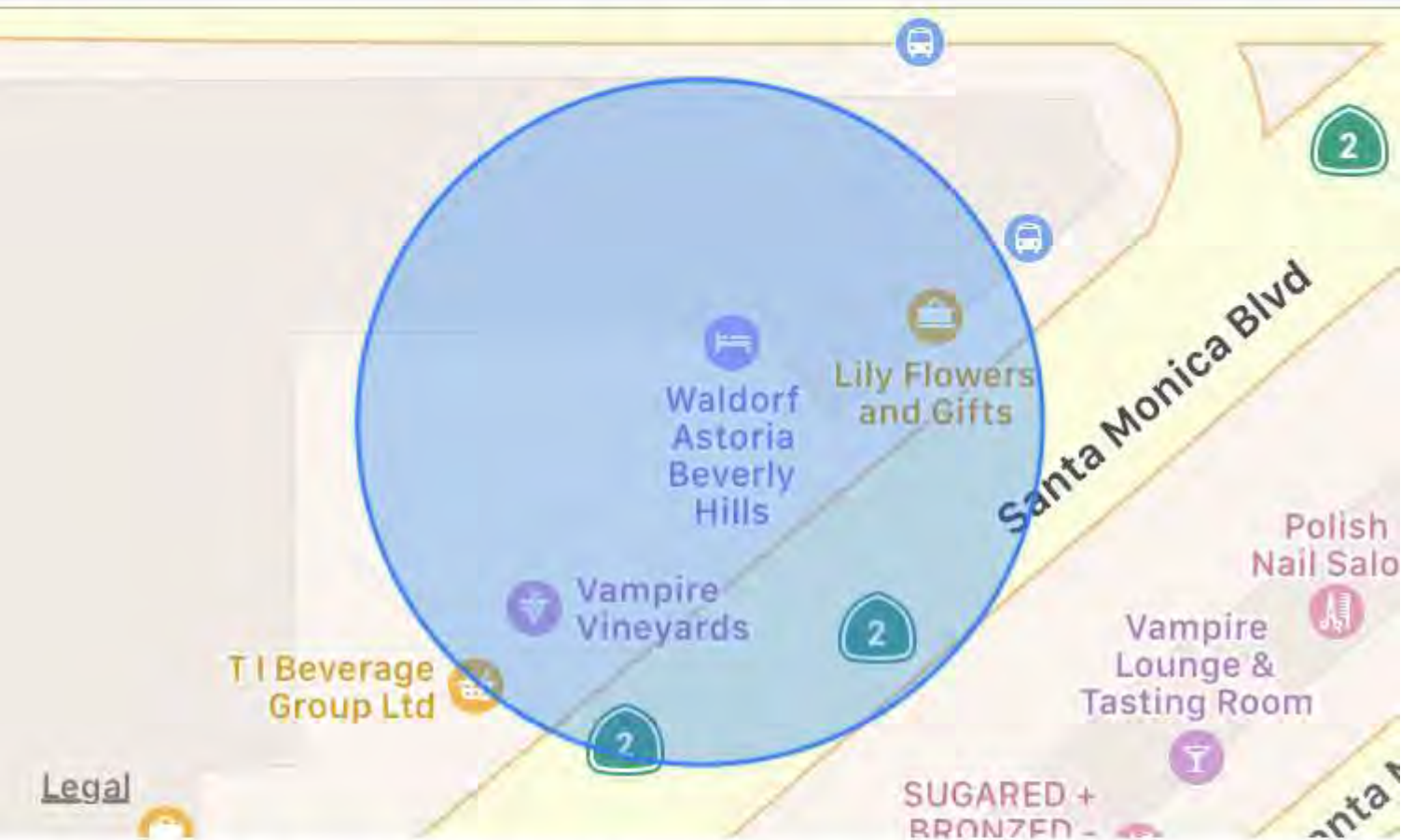

Hello All,

I know that I was supposed to get an email to you guys detailing a step by step process by which Fidelity will be able to issue us title policies. Given my legal proceeding which I am acting as my own attorney (and not by choice), In doing the research for my various responses to Nationstar's onslaught, I have learned so much more and have basically got it down to a science.

The steps that Fidelity needs to take are actually not steps in the underwriting of a policy but in the process of being able to insure its own policy.

Its something I like to call "insuring the insurer." Basically, through our process, Fidelity will be able to issue more policies and preemptively remove any and all claims to the title with no opposition even with full notice.

We can use my "Request for Judicial Notices" as a reference point (see attached).

To be explained Further:

1. Find previous "Beneficiary" when Patrick and Co., brings an order for a title policy
2. Find verification of void transaction/assignment/anything that breaks the chain
3. Issue Policy thereby solidifying bonafide purchaser Defense
4. Complete Sale
5. Immediate Initiation of ex parte quiet title action and Serving only address on the SEC.gov with no need to notice "Servicer"
6. Default Judgment should issue but if, through some impossibility there is response, refer to defenses of void transactions, holder in due course, note holder standing, 3rd party bonafide purchaser etc.

Just to put it in perspective, here is an excerpt from Nationstar's 10K Form Registration in 2012:

"Sale of Mortgage Loans - Transfers of financial assets are accounted for as sales when control over the assets has been surrendered by us. Control over transferred assets is deemed to be surrendered when (i) the assets have been isolated from us, (ii) the transferee has the right (free of conditions that constrain it from taking advantage of that right) to pledge or exchange the transferred assets, and (iii) we do not maintain effective control over the transferred assets through either (a) an agreement that entitles and obligates us to repurchase or redeem them before their maturity or (b) the ability to unilaterally cause the holder to return specific assets. Loan securitizations structured as sales as well as whole loan sales are accounted for as sales of mortgage loans and the resulting gains or losses on such sales, net of any accrual for standard representations and warranties, are reported in operating results as a component of gain/(loss) on mortgage loans held for sale in the consolidated statement of operations during the period in which the securitization closes or the sale occurs."
