Robb Evans & Associates LLC, Receiver over the assets of DebtWorks, Inc. and Andris Pukke ("Receiver"), hereby submits its notice of non-opposition to the motion for stay of Magistrate Judge Day's Memorandum Order dated October 12, 2006 or in the alternative, for an extension of time for the parties to perform under the Memorandum Order pending the District Court's determination of the Motion to Reconsider, Modify or Set Aside the Order ("Objection") filed by John Vipulis ("Vipulis") and Rachlin Cohen & Holtz, LLP ("Rachlin") and the Receiver's Opposition to the Objection to Magistrate Judge Day's Order Dated October 12, 2006 and Motion to Reconsider, Modify or Set Aside ("Receiver's Opposition").

On November 13, 2006, Vipulis filed a motion seeking to stay Magistrate Judge Day's memorandum order dated October 12, 2006 ("Stay Motion")<sup>1</sup> directing that Rachlin produce
