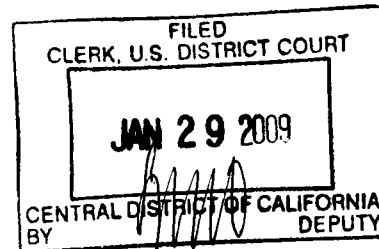

1 November 30, 2008, and good cause being shown, the Court hereby **ORDERS,**  
2 **ADJUDGES, AND DECREES AS FOLLOWS:**

3 1. The Final Report of Fund Administrator's Activities, July 1, 2008 through  
4 November 30, 2008 (the "Final Report") is approved;

5 2. All the acts, transactions and forbearances of the Fund Administrator, its  
6 agents and representatives, as described in the Final Report are approved and ratified.

7 3. The payment of the fees and other expenses of the Fund Administrator, its  
8 staff and attorney, as detailed in the Final Report is approved and authorized;

9 4. The Fund Administrator shall file the tax returns of the Fund; and

10 5. The Fund Administrator shall be discharged without further order of the Court  
11 effective when the Fund Administrator pays the residual funds to the United States Treasury.

12 6. The Fund Administrator shall promptly file proof that  
13 he has paid the residual funds to the treasury. Upon  
such filing, this case shall be closed.
