21 Payment of Receivership Expenses from February 1, 2010 Through December 31,
22 2011 (“Motion”) filed by Robb Evans & Associates LLC as Permanent Receiver
23 (“Receiver”) for Defendant Finbar Securities Corp. (“Finbar”) and its subsidiaries
24 and affiliates, came on regularly for hearing at the above-referenced date, time and
25 place before the Honorable Otis D. Wright II, United States District Judge
26 presiding. Gary Owen Caris of McKenna Long & Aldridge LLP appeared on
27 behalf of the Receiver; David S. Brown appeared on behalf of plaintiff Securities

1 the record. The Court having reviewed and considered the Motion and all
2 pleadings and papers filed in support thereof and opposition, if any, to the Motion,
3 and having heard and considered the arguments of counsel, and good cause
4 appearing therefor,

5 IT IS ORDERED that the Motion and the relief sought therein is granted; and

6 IT IS FURTHER ORDERED that the Receiver's and Receiver's counsel's
7 fees and expenses incurred during the nineteen-month period from February 1,
8 2010 through December 31, 2011, comprised of the fees and expenses of the
9 Receiver, the Receiver's deputies, agents, and staff of \$35,214.92 and legal fees of
10 \$41,194.35 and expenses of \$1,344.82 for the services of the Receiver's counsel,
11 McKenna Long & Aldridge LLP, for a total sum of \$77,754.09, are hereby
12 approved and authorized to be paid from receivership assets.
