**NOTICE OF FILING OF RECEIVER'S MOTION FOR APPROVAL
AND AUTHORIZATION FOR PAYMENT OF RECEIVER'S
AND PROFESSIONALS' FEES AND EXPENSES FOR THE PERIOD
FROM SEPTEMBER 1, 2016 THROUGH APRIL 30, 2017**

PLEASE TAKE NOTICE that the Receiver, Robb Evans and Robb Evans & Associates LLC ("Receiver"), has filed with the above-referenced Court the Receiver's Motion for Approval and Authorization for Payment of Receiver's and Professionals' Fees and Expenses for the Period From September 1, 2016 Through April 30, 2017 ("Motion"). Pursuant to the Motion, the Receiver moves the Court for an order approving and authorizing payment of the Receiver's and professionals' fees and expenses incurred in the eight-month period from September 1, 2016 through and including April 30, 2017 ("Expense Period"), including the following:

A. Receiver's fees of \$26,785.65 and Receiver's expenses of \$2,829.58, for a total of \$29,615.23;

B. Attorneys' fees in the amount of \$293,937.00 and costs of \$28,161.81 incurred to the Receiver's lead counsel, Diamond McCarthy LLP ("Diamond McCarthy"), for a total of \$322,098.81;

C. Attorneys' fees in the sum of \$8,651.45 and costs of \$446.55 incurred to the Receiver's local counsel, Wyatt Tarrant & Combs, LLP, for a total of \$9,098.00; and

D. Attorneys' fees in the sum of \$9,146.30 and costs of \$597.52 incurred to the Receiver's Florida local bankruptcy counsel, Carlton Fields, for a total of \$9,743.82.

The Receiver further moves the Court for an order approving notice of the Motion as sufficient based on (a) service of the Motion and all supporting papers on the parties to this action; (b) service of this Notice of Filing of the Motion on all known non-consumer, non-employee creditors of the receivership estate with the Receiver offering to provide a complete copy of the Motion to any interested party upon written request; and (c) posting of the Motion and supporting pleadings, exclusive of time and billing records, on the Receiver's web site for this case.

PLEASE TAKE FURTHER NOTICE that the Motion is made pursuant to Local Civil Rule 7.1, the Stipulated Preliminary Injunction filed May 28, 2013 (Doc. No. 134) and the Stipulated Order for Permanent Injunction and Monetary Judgment entered on May 9, 2014 (Doc. No. 202) and is made and based on this separate Notice of Filing of the Motion, the Motion, the memorandum of points and authorities and declarations of Brick Kane and Gary Owen Caris and proposed order granting the Motion filed with the Court concurrently herewith, the other pleadings, records and files of the Court in this case of which the Receiver requests the Court take judicial notice, and on such further oral and documentary evidence and arguments of counsel as may be presented at any hearing that may hereafter be set on the Motion.
