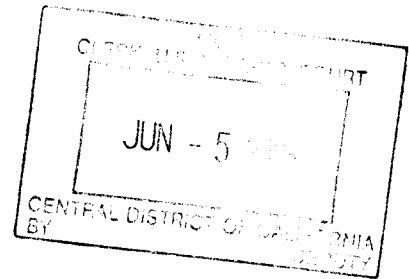

1 came on regularly for hearing on June 5, 2006, at 1:30 p.m. in Courtroom 16 of the

3 presiding. Gary Owen Caris of McKenna Long & Aldridge LLP appeared on
4 behalf of the Receiver and other appearances were made as noted in the record.
5 The Court, having read and considered all papers filed in support of the Motion,
6 having read the executed version of the Settlement Agreement entered into between
7 the Receiver and Techniglove International, Inc. (“Techniglove”), a true and correct
8 copy of which is attached to the Motion as Exhibit 1 (“Settlement Agreement”), no
9 opposition to the Motion having been filed despite due and proper notice having
10 been given, having heard and considered the arguments and contentions of counsel,
11 and good cause appearing therefor, it is

12 ORDERED that:

- 13 1. The Motion shall be and hereby is granted in its entirety;
- 14 2. The Settlement Agreement is approved and the Receiver is authorized
15 to sign and enter into the Settlement Agreement, to sign and enter into all other
16 documents, instruments and papers described in the Settlement Agreement or
17 necessary or convenient to make and implement the Settlement Agreement, to make
18 the releases provided for in the Settlement Agreement, and to perform such other
19 acts necessary or convenient for the Receiver to obtain the benefits and perform all
20 obligations under the Settlement Agreement;
- 21 3. Daniel Heath’s stock and ownership interest in Techniglove shall be
22 and hereby is cancelled; and
- 23 4. Pursuant to the Settlement Agreement, Techniglove shall forthwith
24 reissue new shares in Techniglove to the Receiver in the name of Robb Evans, as
25 Receiver of D.W. Heath & Associates, Inc., et al. (“Substitute Stock”). The

1 Substitute Stock shall provide the Receiver with an ownership interest in
2 Techniglove to the same extent as the ownership interest held by Daniel Heath prior
3 to cancellation of his stock.


