1 Evans & Associates LLC ("Receiver"), the Receiver appointed pursuant to the Court's
2 Preliminary Injunction Order issued February 10, 2011 ("Preliminary Injunction"), came on
3 regularly for determination by the Court, the Honorable Miranda M. Du, United States District
4 Judge presiding. The Court having reviewed and considered the Motion and the pleadings and
5 papers filed in support thereof, and response or opposition to the Motion, if any, and good cause
6 appearing therefor,

7 IT IS ORDERED that:

8 1. The Motion and all relief sought therein is granted;

9 2. Without limiting the generality of the foregoing:

10 A. The Receiver's proposed Settlement Agreement and Release ("Anthon Lots
11 Settlement") with defendant Anthon Holdings Corp. ("Anthon"), Accu-Form Plastics Inc. ("Accu-
12 Form"), and defendant Duane Fielding ("Fielding"), a true and correct copy of which is attached
13 as Exhibit 1 to the Declaration of Gary Owen Caris filed in support of the Motion, is hereby
14 approved;

15 B. The Receiver is authorized to take all steps necessary or convenient to implement
16 and perform under the Anthon Lots Settlement;

17 C. Notice of the Motion is hereby deemed to be sufficient under Local Civil Rules
18 66-5 and 66-10 based on the Receiver's service of the notice of the filing of the Motion and the
19 Motion on all parties and service of the notice of the filing of the Motion on all known non-
20 consumer creditors of the estate, and on all known taxing authorities with a potential claim in the
21 receivership estate concurrent with the filing of the Motion with the Court.
