24 PLEASE TAKE NOTICE that no less than 10 days after service of this Notice, plaintiff
25 Cathay Bank ("Bank") will submit to the Court in the above-entitled action the Stipulation entered
26 into by and among Robb Evans and Associates LLC, the duly appointed and acting receiver
27 ("Receiver") for defendant K2DC Holdings ("K2DC"), the Bank, and defendant K2DC requesting
28 that the Court issue an order (1) approving the final report of the Receiver's activities &



1 accounting from inception through August 31, 2008, including the Receiver's request for discharge
2 set forth therein; (2) discharging the Receiver; and (3) exonerating the Receiver's bond and
3 Plaintiff's bonds. The Stipulation is made in lieu of a noticed motion based on the fact that there
4 are no proceeds to pay creditors other than the Bank, which is the primary secured lender for
5 K2DC. Excluding the payment of the Receiver's fees and expenses and after applying the net
6 proceeds of the Court-approved sale of K2DC's assets of \$1 million and the cash remaining sum of
7 \$85,593.58 belonging to K2DC towards the secured debt, the amount owing to the Bank by K2DC
8 still exceeds \$2.7 million; consequently, there are no proceeds or other assets available to pay any
9 other creditors.
